1. Foreword

We would like to inform you clearly and transparently about the use of cookies when you use our platform. This cookie policy is coordinated with our privacy policy.

2. Preamble

- 1 To enable you to benefit from the services offered by our platform, such as consultation, optimization of use or personalization, our platform uses cookies.
- 2 You may deactivate the cookies to which you have consented at any time, free of charge, using the deactivation options available to you online or in writing.
- 3 This policy is formulated in application of the following regulations:
 - Article 82 of the French Data Protection Act;
 - The General Data Protection Regulation (2016/679) (or "RGPD") and in particular Article 7 relating to the procedures for obtaining consent ;
 - The Cnil guidelines of September 17, 2020 ;
 - Cnil recommendations of September 17, 2020.

3. Definition

- 4 When using our platform, information relating to the browsing of your terminal (computer, tablet, smartphone, etc.) on our platform may be recorded in text files called "cookies", installed on your browser. Cookies are used to recognize your browser for the duration of the cookie's validity. A cookie is a file activated in read or write mode. On telephony equipment, these tracers are equipment identifiers.
- 5 There are different type of cookies:
 - Technical cookies, including session cookies;
 - Functional cookies that allow you to manage the duration of your consent;
 - Audience cookies, which remain on your terminal until their lifetime expires, or until you delete them using your browser's functions.
- 6 You are informed that, when you connect to our platform, cookies may be installed and consulted over time.

4.1 Introduction

- 7 The purposes are determined by the nature of the cookies.
- 8 Cookies are used by our platform for different purposes and are subject to your prior consent.
- 9 Some cookies, which are not subject to your consent, are essential to the use of our platform. These are technical or functional cookies used for :
 - Guaranteeing your identity ;
 - Saving your choices regarding cookies.

4.2 Functional and technical cookies

- 10 These cookies, which are not subject to prior consent, are used for the following main functions:
 - Authentication of your access to our services;
 - Technical management of your session.

4.3 Audience cookies

- 11 The following purposes are subject to your consent:
 - Audience measurement ;
 - Traffic statistics.

6. Consent

¹⁵ The first time you visit our platform, you will be invited to accept or refuse the use of all our cookies and third-party cookies through a "Cookies" consent pop-up..

6.1 Cookie management module

- 16 This module allows you to choose which cookies you accept and which you reject on the platform.
- 17 You can go to the "Cookies" consent pop-up, at any time, to change your preferences.
- 18 You can also give your consent independently and specially for each separate purpose, using the "Set cookies" option.
- 19 You also have the option of leaving the "Cookies" consent pop-up by clicking "Continue without accepting". Please note that by continuing to browse the site without clicking on one of the options proposed by the Cookies pop-up, you will be deemed to have expressed a refusal.
- 20 When you accept cookies, a consent cookie is stored on your terminal.
- 21 If you do not want cookies to be set or read on your terminal, a refusal cookie will be stored on your equipment for six (6) months, so that we can save the information that you have objected to the use of cookies.
- ²² If you delete this refusal cookie, it will no longer be possible to know that you refused cookies. This is why the refusal or consent cookies should remain on your terminal.

6.2 Browser settings

- 23 You can adjust the settings of your browser so that it systematically accepts or rejects all cookies or only cookies from certain issuers.
- 24 You can also regularly delete cookies from your terminal using your browser.
- 25 Remember to adjust the browser settings on each of your terminals.
- ²⁶ Each browser has its own way of managing cookies and cookie settings. Go to the "Help" menu of each browser to know how to change cookie settings. For example:

7. Rights of data subjects

- ³⁰ The storage period is defined according to the type of cookie. These periods are specific to each cookie or tracker.
- 31 You have the right to access, rectify, delete and port your data, as well as the right to limit processing.
- 32 You also have the right to object on grounds relating to your particular situation, at any time, to the processing of personal data based on your legitimate interests.
